ORDERS

Reference your representation dated 15.06.2020 & copy of letter dated 25.06.2020.

I, Amit Kumar, Chief Executive Officer, Pune Cantonment Board and INCIDENT COMMANDER of Pune Cantonment area, having been designated the powers under the Indian Epidemic Disease Act, 1897, hereby pass revised orders for opening of Clover Centre w.e.f. 1st July, 2020.


All shops in the Clover Centre shall operate on P1 & P2 basis from 9.00 am to 8.00 pm. The following norms should be strictly adhered to -

- i. Social distancing shall be maintained and the respective shop owners / traders shall be responsible for compliance of social distancing norms for the customers visiting the shops / business establishment. If social distancing is not followed, the concerned shop will be fined and on repetition will be closed temporarily. It shall be ensured by the shopkeepers and business establishments that no goods are displayed beyond the shop / stalls.
- iii. Thermal scanners to be provided at the entrance / all the gates. Sanitizers be provided at all the entry & exit points. Arrangement be made by the Society.
- iv. All the shops should be sanitized before the operation of the shops.
- v. Wearing of masks should be made compulsory and no entry be allowed without mask.
- vi. **PENALTY :**

- i. Non-wearing of mask would attract a fine of Rs.100/- per offence.
- ii. Spitting in public places will attract fine of Rs.500/- per offence.
- iii. Shopkeepers / vendors shall be penalized for non maintenance of social distancing Rs.1,000/- for first offence, Rs.2,000/- for second offence, Rs.3,000/- for third offence and forceful closure of shop for the fourth offence.

- iv. The Patrolling team of Police and Cantonment Board till further orders by the Incident Commander / CEO is authorized to shut down the shop / business establishment if they are found violating the norms of social distancing and / any of the above violations.

The CEO / Incident Commander / Board reserves the right to close any of the shops without affording any opportunity to be heard, if considered essential in public interest to contain spread of COVID 19 or otherwise. This Order will be in force till further orders.
